Motion carried 5-0.

Motion by Scherer with a second by VanArsdol to approve the hiring of Kelsey Cowgill as HS Spanish Teacher for the 2024-2025 school year. Motion carried 5-0.

Motion by Arnold with a second by Scherer to approve the hiring of Ethan Flaharty as Assistant Boys Soccer Coach for the 2024 season and Savanna Huseman as eSports sponsor for the 2024-2025 school year. Motion carried 5-0.
